2.	Composition / Indications to components	<b>Chemical characterization :</b> Polyamide 66 (PA66) <b>Hazardous substances:</b> Product contains no hazardous ingredients liable to be disclosed.
3.	Possible dangers	<b>Classification :</b> Not classified <b>Physical/ chemical hazards :</b> Flammable <b>Health risks:</b> Dust can cause mechanical irritation. <b>Hazards for the environment:</b> Based on our information, there is no danger to the environment. The product is according to Directive 1999/45/EC and its annexes are not classified as dangerous.
